An ordinance to amend Ordinance No. 05-376  
creating the Washington Parish Planning Commission

**BE IT ORDAINED** by the Washington Parish Council duly convened in regular session as required by applicable federal and state laws and regulations, that it does hereby enact the following ordinance creating the Washington Parish Planning Commission.

**Section 1. Created.**

There is hereby created the planning commission.

**Section 2. Membership**

- (a) **The parish planning commission shall consist of nine members, seven to be appointed by the parish council and two at large appointments by the Parish President**
- (b) **Terms will be as follows: Three (3) appointees shall serve four (4) year terms, three (3) appointees shall serve five (5) year terms and three (3) shall serve three (3) year terms.**
- (c) **If a vacancy occurs otherwise than by expiration of the term, it shall be filled by the original appointing authority for the unexpired term.**

**Section 3. Jurisdiction.**

The planning area under the jurisdiction of the parish planning commission shall be the unincorporated area of the parish.

**Section 4. Powers and duties.**

The powers and duties of the parish planning commission shall be as provided by law, particularly as set forth in LA R.S. 33:106 et seq., except that no master plan is or shall be required as a matter of law for the unincorporated areas of the parish within the jurisdiction of the parish planning commission. **The Washington Parish Council will retain the authority to approve and enforce the regulations recommended by the parish planning commission.**

**Section 5. Acceptance of subdivisions.**

- (a) **In accordance with the provisions of LA R.S. 33:101, et seq. and chapter 20.5 of this code, the parish planning commission shall approve or disapprove subdivision developments and this shall act as a final acceptance of the said**

subdivision or rejection of the said subdivision except as provided herein below at subsection (b).

- (b) For good cause shown, the parish council reserves unto itself the right to grant a variance to the existing subdivision regulations. In cases where the literal requirements of the subdivision regulations would not create an undue hardship and the granting permission to depart from the literal requirements of the subdivision regulations would not create a hazardous situation nor impact the rights of adjoining property owners or the public, the parish council reserves the right to grant variances to the existing subdivision regulations.
- (c) The above and foregoing notwithstanding, all amendments, additions, deletions or changes in the parish subdivision regulations shall be adopted by ordinance of the parish council

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




