AN ORDINANCE AMENDING ORDINANCE NO. 00-245
TO PROVIDE FOR COMMUNITY SERVICE AS A PART
OF THE PENALTY FOR VIOLATION OF THE LITTER ORDINANCE

WHEREAS the Washington Parish Council did adopt Ordinance No. 00-245 on July 10, 2000 updating the parish litter ordinance; and

WHEREAS the ordinance provides for fines for violation of said ordinance; and

WHEREAS, it is the desire of the Washington Parish Council that the requirement of community service work be included in the Penalty for Violation section of the ordinance.

THEREFORE BE IT ORDAINED that the PENALTY FOR VIOLATION section of Ordinance No. 00-245 be amended to read as follows:

Any person violating any of the provisions of this article shall be deemed guilty of a misdemeanor and upon conviction thereof, shall be

E. (1) Whoever violates the provisions of this Section shall, upon first conviction, be fined not less than fifty dollars nor more than three hundred dollars and complete 8 hours of community service.

(2) Upon second conviction, an offender shall be fined not less than two hundred fifty dollars or more than five hundred dollars and complete 40 hours of community service.

(3) Upon third or subsequent conviction, an offender shall be fined five hundred dollars and/or imprisoned for not more than thirty days and complete 120 hours of community service.

F. Anyone convicted of violating Section C of this ordinance, shall be fined no more than five thousand dollars.

G. For the purposes of this Section, each occurrence shall constitute a separate violation.

The above having been submitted to a vote, a roll call vote resulted as follows:
