**A resolution expressing the intent of the Washington Parish Council to re-adopt the Residential Anti-Displacement and Relocation Assistance Plan for Louisiana Community Development Block Grant (LCDBG) Programs, for the Parish's fiscal year 2017 Louisiana Community Development Program and all future programs, until such time as the requirements for the plan change under the LCDBG Program.**

The following resolution was offered for adoption on motion by Councilman Fussell and seconded by Councilman Workman.


