**RESOLUTION BY THE WASHINGTON PARISH COUNCIL TO  
AUTHORIZE THE PARISH PRESIDENT TO SIGN AN AGREEMENT  
BETWEEN BARRIERE CONSTRUCTION CO. L.L.C. AND WASHINGTON  
PARISH GOVERNMENT FOR ASPHALT OVERLAY ON GREENTREE  
DRIVE AND DOLLAR ROAD**

**WHEREAS**, The Washington Parish Government, a political subdivision of the State of Louisiana, requests authorization by the laws of the State of Louisiana to enter into an agreement with Barriere Construction Co. L.L.C. for asphalt overlay on Greentree Drive, Bogalusa and Dollar Road, Varnado, La.; and

**WHEREAS** in the best interest of the public, the Washington Parish Government desires to make improvements to Greentree Drive and Dollar Road; and

**WHEREAS**, Washington Parish Government has solicited proposals from capable entities concerning the scope of such work, and

**AND WHEREAS**, Barriere Construction Co. L.L.C. provided the lowest cost proposal based on the Scope of Work of herein referenced project,

**BE IT RESOLVED**, that the Washington Parish council, being the governing authority of the Parish of Washington, State of Louisiana, met in a regular session on May 20, 2019 and approved an agreement between Washington Parish Government and Barriere Construction Co. L.L.C. for asphalt overlay on Greentree Drive, Bogalusa and Dollar Road, Varnado, La. for the Public Benefit.

**FURTHER BE IT RESOLVED**, that Washington Parish Council hereby authorizes the Parish President to sign an agreement between Washington Parish Government and Barriere Construction Co. L.L.C. for asphalt overlay on Greentree Drive, Bogalusa and Dollar Road, Varnado, La.


