ORDINANCE AMENDING ORDINANCE No. 18-635 TO ESTABLISH LENGTH OF ROAD AS A MEASUREMENT IN FOOTAGE

WHEREAS, Pine Cone Lane was accepted as a parish road into inventory as Inventory List Road No. 7-174 by act of Ordinance No. 18-635 being declared adopted on 25th day of June 2018; and

WHEREAS, Ordinance No. 18-635 described the boundaries of that parcel of land to wit:

That certain parcel of land located in Sections 25 & 26, Township 1 South, Range 13 East, forty (40) feet in width, being twenty (20) feet on each side of the centerline of that certain road identified as Pine Cone Lane and formerly known as Cora Williams Road, extending from H H Williams Road in a southeasterly direction to the West line of a parcel of land acquired by Nathan Alan Williams from A.C. Williams, et al., by act dated July 14, 1986 of record in COB 367, Page 652, Washington Parish, Louisiana;

WHEREAS, acceptance of the Act of Dedication describes the boundaries of the road, and currently no measure of footage describes this road as listed on the Parish DPW inventory list for maintenance.;

THEREFORE, in order to establish the length of the road in footage and for further description, the Director of Public Works has inspected the above described road and determined that the length of Pine Cone Lane as originally accepted to be the length of 2,200 feet.

BE IT RESOLVED, that the Parish Council does hereby accept for further inventory description, an amendment to Ordinance No. 18-635 establishing the length of the road as 2,200 feet.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:






