**A RESOLUTION EXPRESSING THE INTENT OF THE WASHINGTON PARISH COUNCIL TO RE-ADOPT THE RESIDENTIAL ANTI-DISPLACEMENT AND RELOCATION ASSISTANCE PLAN FOR LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT (LCDBG) PROGRAMS, FOR THE PARISH'S FISCAL YEAR 2019 LOUISIANA COMMUNITY DEVELOPMENT PROGRAM UNTIL SUCH TIME AS THE REQUIREMENTS FOR THE PLAN CHANGE UNDER THE LCDBG PROGRAM.**

**WHEREAS**, the Washington Parish Council has received approval for a Louisiana Community Development Block Grant (LCDBG) for the 2019 Fiscal Year; and

**WHEREAS**, the LCDBG Program requires that all grant recipients adopt by resolution a Residential Anti-Displacement and Relocation Assistance Plan; and

**WHEREAS**, the Parish adopted the Residential Anti-Displacement and Relocation Assistance Plan for a previously funded LCDBG grant; and

**WHEREAS**, the previously adopted plan is still in effect and will be used for ongoing grants as well as the FY 2019 program;

**NOW THEREFORE, BE IT RESOLVED** by the Parish Council, as the governing authority of the Parish that the Washington Parish Council hereby states its intent to re-adopt the Residential Anti-Displacement and Relocation Assistance Plan, to be used for ongoing projects and the recently awarded 2019 FY LCDBG Program until such time as the LCDBG Program Requirement for the Plan change.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:




