RESOLUTION BY THE WASHINGTON PARISH COUNCIL TO AUTHORIZE THE PARISH PRESIDENT TO SIGN AN AGREEMENT BETWEEN BARRIERE CONSTRUCTION CO. L.L.C. AND WASHINGTON PARISH GOVERNMENT FOR ASPHALT OVERLAY ON POPE RD., BONNER CREEK RD. AND DOLLAR RD.

WHEREAS, The Washington Parish Government, a political subdivision of the State of Louisiana, requests authorization by the laws of the State of Louisiana to enter into an agreement with Barriere Construction Co. L.L.C. for asphalt overlay on Pope Rd, Bonner Creek Rd and Dollar Rd, Washington Parish, La.; and

WHEREAS in the best interest of the public, the Washington Parish Government desires to make improvements to Pope Rd, Bonner Creek Rd and Dollar Road; and

WHEREAS, Washington Parish Government has solicited bids from capable entities concerning the scope of such work, and

AND WHEREAS, Barriere Construction Co. L.L.C. provided the lowest cost bid based on the Scope of Work of herein referenced project,

BE IT RESOLVED, that the Washington Parish council, being the governing authority of the Parish of Washington, State of Louisiana, met in a regular session on August 12, 2019 and approved an agreement between Washington Parish Government and Barriere Construction Co. L.L.C. for asphalt overlay on Pope Rd, Bonner Creek Rd and Dollar Road, Washington Parish, La. for the Public Benefit.

FURTHER BE IT RESOLVED, that Washington Parish Council hereby authorizes the Parish President to sign an agreement between Washington Parish Government and Barriere Construction Co. L.L.C. for asphalt overlay on Pope Rd, Bonner Creek Rd and Dollar Road, Washington Parish, La.
