**RESOLUTION BY THE WASHINGTON PARISH COUNCIL IN SUPPORT OF WELCOME SIGNS PLACEMENT AT THE PARISH LINE HIGHWAY BOUNDARIES LOCATED ON HIGHWAY 21 NORTH OF SUN, LA AT PARISH LINE; HWY 10 EAST OF BOGALUSA NEAR PEARL RIVER BRIDGE; HWY 21 NORTH OF ANGIE AT PARISH LINE; HWY 25 NEAR WARNERTON AT PARISH LINE; HWY 16 WEST AT TANGIPAHOA PARISH LINE; HWY 25 SOUTH BETWEEN FRANKLINTON AND FOLSOM.**

**NOW THEREFORE BE IT RESOLVED** the Washington Parish President and Parish Council hereby by act of Resolution support the placement of "200 Year Celebration Welcome Signs" at the Parish line boundaries located on Highway 21 North of Sun, La.at Parish line; Highway 10 East of Bogalusa near Pearl River Bridge; Highway 21 North of Angie at Parish Line; Highway 25 near Warnerton at Parish line; Highway 16 West at Tangipahoa Parish Line; and Highway 25 South Between Franklinton and Folsom


