

RESOLUTION NO. 19-957

A RESOLUTION REQUESTING THAT THE LOUISIANA DEPARTMENT OF TRANSPORTATION & DEVELOPMENT PERMIT AND INSTALL GUIDE SIGNS, "WASHINGTON PARISH EMERGENCY OPERATIONS CENTER", ON LOUISIANA STATE HIGHWAY 10 RIGHT OF WAY DIRECTING THE PUBLIC TO THE WASHINGTON PARISH EMERGENCY OPERATION COMMUNICATIONS CENTER LOCATED ON DOLLAR ROAD IN WASHINGTON PARISH.

WHEREAS, the current sign providing directions to the Washington Parish Emergency Operation Center is located at the intersection of State Hwy. 10 and Dollar Road on LSU Department of Agriculture property; and

WHEREAS, there is a proposal to convert the same LSU Department of Agriculture property into a Veterans Memorial park; and

WHEREAS, the current sign providing directions to the Washington Parish Emergency Operation Center would need to be relocated to State Hwy 10; and

WHEREAS, the Washington Parish Communications Center (911) houses the Washington Parish Emergency Operations Center (FEOC); and

WHEREAS, the Washington Parish Communications District was created by the Washington Parish Government on May 17, 1988 under the provisions authorized by Louisiana Revised Statute 33:9101-9106 and that District is a political and legal subdivision of the state of Louisiana; and

WHEREAS, the Washington Parish Communications Center is open for public business eight hours a day for at least five days a week and has at least twelve public meetings per year;

THEREFORE, BE IT RESOLVED, the Washington Parish President and Parish Council hereby request the Louisiana Department of Transportation & Development to permit and install guide signs, "Washington Parish Emergency Operations Center", on Louisiana State Highway 10 Right of Way directing the public to the Washington Parish Communications Center located on Dollar Road in Washington Parish.




