**RESOLUTION BY THE WASHINGTON PARISH COUNCIL TO AUTHORIZE
THE PARISH PRESIDENT TO SIGN AN INTERGOVERNMENTAL
AGREEMENT WITH THE TOWN OF FRANKLINTON FOR SIDEWALK
IMPROVEMENTS IN DOWNTOWN FRANKLINTON THROUGH STATE PROJECT
NO. H011835 AND FEDERAL PROJECT NO. H011835**

WHEREAS, Article VII, Section 14(C) of the Constitution of the State of Louisiana provides that "for a public purpose, the state and its political subdivisions... may engage in endeavors with each other,

WHEREAS, under the provisions of Title 23, United States Code, "Highways," as amended, funds have been appropriated out of the Federal Highway Trust Fund to finance improvement projects under the direct administration of DOTD; and

WHEREAS, Washington Parish Government has requested an appropriation of funds to finance a portion of the above referenced Project; and

WHEREAS, The Town of Franklinton is agreeable to the implementation of the Project and desires to cooperate with Washington Parish Government; and

WHEREAS, Washington Parish Government and the Town of Franklinton each has a demonstrable, objective, and reasonable expectation of receiving a public benefit or value at least equivalent to the amount each party shall expend or contribute to this project, and

WHEREAS, in consideration of these services and advantages to be received by the general public as provided by TOWN, PARISH, STATE and FEDERAL,

BE IT RESOLVED that Washington Parish Council hereby authorizes the Parish President to sign an Intergovernmental Agreement with the Town of Franklinton for implementation of sidewalk improvements in downtown Franklinton through State Project No. H.011835 and Federal Project No. H.011835

BE IT FURTHER RESOLVED, that this resolution was introduced and adopted at a regular called meeting of the Washington Parish Council, a quorum being present and voted upon.



**INTERGOVERNMENTAL AGREEMENT BETWEEN WASHINGTON
PARISH GOVERNMENT AND THE TOWN OF FRANKLINTON FOR
DOTD FEDERAL AID SIDEWALK PROJECT H.011835**

PARISH OF WASHINGTON

BE IT KNOWN, that on the dates herein set forth, before the undersigned Notaries Public commissioned in and for the Parish of Washington, State of Louisiana, and in the presence of the witnesses hereinafter named and undersigned, personally came and appeared:

THE WASHINGTON PARISH GOVERNMENT, whose mailing address is 909 Pearl Street, Franklinton, Louisiana 70438, represented herein by Richard "Ned" Thomas, Jr., President, duly authorized, hereinafter referred to as the "Parish"

And

THE TOWN OF FRANKLINTON, a political subdivision, having a mailing address of 301 11TH Ave., Franklinton, Louisiana 70438, represented herein by Richard Dillon, its Mayor, duly authorized, hereinafter referred to as the "Town of Franklinton"

Who do by these presents enter into the following agreement, to-wit:

1.

As authorized by Article 7 Section 14(C) of the Constitution of the State of Louisiana, and La. R.S. 33:1324, et seq., the "Parish" and the "Town of Franklinton" are authorized to enter into an Intergovernmental Agreement.

2.

And, under the provisions of Title 23, United States Code, "Highways," as amended, funds have been appropriated out of the Federal Highway Trust Fund to finance a sidewalk improvement project in the Town of Franklinton under the direct administration of DOTD; and

3.

The "Town of Franklinton" is agreeable to the implementation of the Sidewalk Project and desires to cooperate with Washington Parish Government; and

4.

The "Parish" under the provisions of Title 23, United States Code, "Highways," as amended, funds have been appropriated out of the Federal Highway Trust Fund to finance a sidewalk improvement project in the Town of Franklinton under the direct administration of DOTD; and

5.

Washington Parish Government and the Town of Franklinton each has a demonstrable, objective, and reasonable expectation of receiving a public benefit or value at least

equivalent to the amount each party shall expend or contribute to this project, and

6.

The Sidewalk Project shall be under the exclusive supervision of the "Parish" through its Public Works Director. The construction is to take place at a time to be determined by the "Parish" and Contractors at their own discretion.

7.

The "Town of Franklinton" shall not be called upon to assume any liability of the direct or indirect payment of any equipment, salaries, wages, benefits or other compensation owed to any vendor, employee or agent of the "Parish". The "Parish" hereby assumes such liabilities.

8.

The "Town of Franklinton" agrees to indemnify and hold harmless the "Parish" and its employees and/or agents from and shall defend and indemnify the "Parish" and its employees and/or agents against any claim for damages arising out of the performance of this Agreement.

9.

This agreement may be terminated upon giving written notice to the other party.


