**AN ORDINANCE TO ABANDON
1,366.20 FEET OF THE WESTERN PART OF BRANCH DRIVE
AS DEDICATED IN AN ACT OF DEDICATION EXECUTED JULY 12, 1966**

WHEREAS, Branch Drive, Bogalusa is 2,091.6 feet in length and 50 feet wide and extends West off State Hwy 21 (South Columbia Rd., Bogalusa) parallel and North of Brookwood Drive as dedicated in an Act of Dedication executed July 12, 1966, and

WHEREAS, Branch Drive was never maintained by the Parish or assigned a Parish Inventory number and the servitude no longer serves a public need, and

WHEREAS, the property owner at the West end of Branch Drive owns the property on both sides of the servitude that dead ends into their property and have requested that the Parish abandon 1366.20 feet from the Western dead end of Branch Drive, and

WHEREAS, all other adjacent property owners would have full ingress and egress from the Eastern remaining portion of Branch Drive as described in the originating 1966 Act of Dedication,

THEREFORE, BE IT ORDAINED by the Washington Parish Council that 1366.20 feet from the Western dead end of Branch Drive is hereby abandoned by Washington Parish Government, yet subject to any existing utilities and drainage servitudes.


