AUTHORIZE ADVERTISEMENT FOR REQUEST FOR PROPOSALS (RFP)
TO PROVIDE ENGINEERING SERVICES FOR ASSISTANCE IN
COMPLETING WATERSHED INITIATIVE GRANT APPLICATIONS
FOCUSING ON DRAINAGE IMPROVEMENT PROJECTS THROUGH
ELEVATIONS AND CULVERT/BRIDGE UPGRADES**

WHEREAS, The Washington Parish Government, a political subdivision of the State of Louisiana, seeks to complete grant applications through the Louisiana Watershed Initiative Program to improve drainage within the floodplains of Washington Parish, and

WHEREAS, to move forward with applications in the Louisiana Watershed Initiative Program, Washington Parish Government will require an Engineering Firm for technical data, engineering studies, environmental permits, engineering design plans and consultation to complete a valid and competitive application during Round 1 Watershed Initiative applications; and

WHEREAS, to solicit and secure an engineering firm for such services a Request for Proposal (RFP) will be necessary, and

AND WHEREAS, in a diligent effort to secure funding from the Louisiana Watershed Initiative program and in consideration of the advantages to be received by the general public as provided by these services,

BE IT RESOLVED that the Washington Parish Council hereby authorizes the advertisement of Request for Proposals for engineering services and execution of all documents necessary to achieve the purpose of this resolution by the Parish President.




