**RESOLUTION TO PROVIDE LAWN MAINTENANCE  
FOR A PROPOSED VETERANS MEMORIAL PARK**

**WHEREAS**, there is a proposal for the construction of a veterans memorial park to be located in Washington Parish, Louisiana; and

**WHEREAS**, Louisiana State University owns property in Washington Parish, Louisiana and has or will lease property to Our Veterans Memorial Park, Inc., a non-profit corporation, which will plan, construct and maintain the park; and

**WHEREAS**, a veterans memorial park serves a public purpose in honoring veterans for their service to our country; and

**WHEREAS**, the Washington Parish Government has labor and equipment to provide lawn maintenance to the park.

**THEREFORE, BE IT RESOLVED**, that the Washington Parish Government will provide the labor and equipment to perform lawn maintenance consisting of mowing and weed-eating of the veterans memorial park on property owned presently by Louisiana State University and described as being a parcel of land containing 2.7 acres, more or less, being 428.60 feet, more or less, along the north margin of Louisiana State Highway 10; 526.84 feet, more or less, along the south margin of Dollar Road; 56.72 feet, more or less, on the West boundary; and 447.11 feet, more or less, on the East boundary.

**BE IT FURTHER RESOLVED**, that the Washington Parish Government will begin lawn maintenance upon the execution of a lease by Louisiana State University to Our Veterans Memorial Park, Inc., completion of construction of the park and being provided with proof of liability insurance with the Washington Parish Government being an additional insured.




