**RESOLUTION RATIFYING AN INTERGOVERNMENTAL AGREEMENT
BETWEEN THE WASHINGTON PARISH GOVERNMENT
AND THE CITY OF BOGALUSA
AND AN ACT OF TRANSFER AND CONVEYANCE
OF THE CHOCTAW ROAD LANDFILL**

WHEREAS, Ordinance No. 20-663 adopted on February 24, 2020 authorized the Parish President, Richard "Ned" Thomas, Jr., to execute any and all documents necessary to terminate the Choctaw Road Landfill Joint Venture with the City of Bogalusa; to acquire the undivided 41.99% interest of the City of Bogalusa in the Choctaw Road Landfill and to enter into an agreement with the City of Bogalusa for the disposal of residential solid waste at the Choctaw Road Landfill and any other matters related thereto; and

WHEREAS, an intergovernmental agreement and an act of transfer and conveyance was entered into between the Washington Parish Government and the City of Bogalusa executed on May 26, 2020 by the Parish President, Richard "Ned" Thomas, Jr., and executed on May 27, 2020 by the Mayor of the City of Bogalusa, Wendy O'Quinn Perrette, containing all the terms and conditions to accomplish the purposes stated in Ordinance No. 20-663.

BE IT RESOLVED, that the Choctaw Road Landfill intergovernmental agreement between the Washington Parish Government and the City of Bogalusa, executed on May 26, 2020 by the Parish President, Richard "Ned" Thomas, Jr., and executed on May 27, 2020 by the Mayor of the City of Bogalusa, Wendy O'Quinn Perrette, is ratified and confirmed.

BE IT FURTHER RESOLVED, that the act of transfer and conveyance from the City of Bogalusa to the Washington Parish Government executed by the Mayor of the City of Bogalusa, Wendy O'Quinn Perrette, on May 27, 2020 and executed by the Parish President, Richard "Ned" Thomas, Jr., on May 26, 2020 is ratified and confirmed.


