**AN ORDINANCE TO ADOPT THE ADJUSTED MILLAGE RATES FOR 2020
ON PROPERTY SUBJECT TO TAXATION
IN WASHINGTON PARISH**

WHEREAS, the Washington Parish Council, governing authority of the Parish of Washington, State of Louisiana, held a public meeting on July 13, 2020 conducted in accordance with the open meetings law and additional requirements of Article VII, Section 23 (C) of the Louisiana constitution and R.S. 47:1705 (B).

THEREFORE BE IT ORDAINED, by the Washington Parish Council, that the following adjusted millage rates be and they are hereby levied upon the dollar of the assessed valuation of all property subject to Ad Valorem taxation within said Parish for the year 2020, for the purpose of raising revenue.

Exempted Municipalities - Inside.....	1.84 mills
General Alimony - Outside.....	3.69 mills
Health Unit	3.10 mills
Library	4.59 mills
Road & Bridges	4.12 mills
Road & Bridge.....	9.97 mills

BE IT FURTHER ORDAINED, that the Assessor of the Parish of Washington, shall extend upon the assessment roll for the year 2020 the taxes herein levied, and the tax collector of said Parish shall collect and remit the same to said taxing authority in accordance with law.






