**A RESOLUTION AUTHORIZING THE
WASHINGTON PARISH GOVERNMENT
TO APPLY FOR AND ADMINISTER A GRANT THROUGH
THE INFRASTRUCTURE FOR REBUILDING AMERICA (INFRA) PROGRAM**

WHEREAS, the Washington Parish Government intends to apply for a grant through the Infrastructure for Rebuilding America (INFRA) Program; and

WHEREAS, the funds will be used to improve the safety and efficient freight truck traffic operation along the Willis Avenue corridor between Louisiana State Highway 60 and Louisiana State Highway 21 in the City of Bogalusa, Washington Parish, Louisiana; and

WHEREAS, the Washington Parish Government, the City of Bogalusa, Louisiana State Department of Transportation and Development (DOTD), the State of Louisiana and regional private enterprise, each has a demonstrable, objective and reasonable expectation of receiving a public benefit in the form of improved safety and positive economic development at least equivalent to or greater than the amount of each party's contribution, including the Federal share; and

WHEREAS, such a project cannot be completed simply or efficiently without FEDERAL funding,

THEREFORE, BE IT RESOLVED that the Washington Parish Council hereby supports an application of the Washington Parish Government for INFRA grant funds to the benefit of parties mentioned herein and authorizes the Parish President or his designee to sign all forms, applications, reports, plans, notices and all other documents and paperwork necessary to administer the aforementioned project and to accomplish the purpose of this resolution..
