RESOLUTION BY THE WASHINGTON PARISH COUNCIL TO AUTHORIZE THE PARISH PRESIDENT TO SIGN AN AGREEMENT BETWEEN BARRIERE CONSTRUCTION CO. L.L.C. AND WASHINGTON PARISH GOVERNMENT FOR ASPHALT OVERLAY ON LANES ROAD, WELLS ROAD, MACK ADAMS-O'BERRY ROAD, BILL BOOTY ROAD, WILL TALLEY ROAD, HARRY KENNEDY ROAD, FISHER ROAD, C.C. ROAD, CAROL MORGAN ROAD, LAKE CHOCTAW ROAD, CLAUD NOBLES ROAD, HAMMERSTONE ROAD, PINE LANE AND WEST CHOCTAW ROAD

WHEREAS, The Washington Parish Government, a political subdivision of the State of Louisiana, requests authorization by the laws of the State of Louisiana to enter into an agreement with Barriere Construction Co. L.L.C. for asphalt overlay on the above-named roads located in Washington Parish, La.; and

WHEREAS, in the best interest of the public, the Washington Parish Government desires to make improvements to the subject parish roads; and

WHEREAS, Washington Parish Government has solicited bids from capable entities concerning the scope of such work, and

AND WHEREAS, Barriere Construction Co. L.L.C. provided the lowest cost bid based on the Scope of Work of herein referenced project,

BE IT RESOLVED, that the Washington Parish council, being the governing authority of the Parish of Washington, State of Louisiana, met in a regular session on March 22, 2021 and approved an agreement between Washington Parish Government and Barriere Construction Co. L.L.C. for asphalt overlay on the above-named roads located in Washington Parish, La. for the Public Benefit.

FURTHER BE IT RESOLVED, that Washington Parish Council hereby authorizes the Parish President to sign an agreement between Washington Parish Government and Barriere Construction Co. L.L.C. for herein referenced project located in Washington Parish, La.
