**AN ORDINANCE SUPPLEMENTING THE  
"NO THRU TRUCK ROUTES" ORDINANCE AS PER ORDINANCE NUMBER 13-577**

**WHEREAS**, Ordinance No. 13-577 adopted on October 21, 2013 created "NO TRUCK ROUTES" and "NO THRU TRUCK ROUTES" including fines for violations thereof; and

**WHEREAS**, Ordinance No. 13-577 further states that the Washington Parish Council will establish, as needed, the areas of Parish roads that will be designated as "NO THRU TRUCK ROUTES".

**BE IT ORDAINED**, that the following Parish road in the location designated is hereby declared to be "NO THRU TRUCK ROUTE" under the provisions of Ordinance No. 13-577:


