ORDINANCE AUTHORIZING AND DIRECTING THE WASHINGTON PARISH PRESIDENT TO SIGN AND EXECUTE ON BEHALF OF THE WASHINGTON PARISH COUNCIL ANY AND ALL CONTRACTS, PURCHASE AGREEMENTS, DECLARATIONS, APPLICATIONS, AMENDMENTS, AGREEMENTS AND ALL OTHER DOCUMENTS AND PAPERWORK NECESSARY FOR THE APPLICATION, ADMINISTRATION AND CLOSEOUT OF A **FY 2022–2023 LOUISIANA COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC FACILITIES APPLICATION FOR THE BOGUE LUSA WATER WORKS DISTRICT** ON BEHALF OF WASHINGTON PARISH AND ANY POLITICAL SUB-DIVISIONS THEREOF

WHEREAS, the Washington Parish Government intends to apply to the State of Louisiana, Office of Community Development for Louisiana Community Development Block Grants (LCDBG) for eligible activities and has agreed to submit a Louisiana Community Development Block Grant application on behalf of the Bogue Lusa Water Works District for water system improvements; and

WHEREAS, this grant will require a large volume of paperwork from the Parish Council in an expedited manner; and

WHEREAS, the Washington Parish Government has decided to apply for an LCDBG under the FY 2022-2023 program funding cycle for the exclusive benefit of the citizens of Washington Parish; and

THEREFORE BE IT ORDAINED by the Washington Parish Council that the Washington Parish President be and he is hereby authorized and directed to sign and execute on behalf of the Washington Parish Government any and all contracts, declarations, applications, amendments, land purchase agreements, all other multi party agreements and all other documents and paperwork necessary for the application, administration and closeout of the **FY 2022-2023 Louisiana Community Development Block Grant Public Facilities Application for the Bogue Lusa Water Works District** on behalf of the Washington Parish Government and any political subdivisions thereof.

BE IT FURTHER ORDAINED that the Bogue Lusa Water Works District is to pay for Engineering and Administrative Services costs associated with the implementation of the FY2022/2023 LCDBG application for Water System Improvements with invoicing for these services to be directly billed and paid by and through the Bogue Lusa Water Works District.

BE IT FURTHER ORDAINED by the Washington Parish Council that this ordinance shall take effect immediately upon the signature of the Washington Parish President.
