**AN ORDINANCE TO ABANDON  
0.15 MILES OF ROBERT STUART  
PARISH ROAD NO. 5-153**

**WHEREAS**, 0.15 miles of Robert Stuart Road no longer serves a public need:

**WHEREAS**, all property owners on Robert Stuart Road agree that the Parish Government should abandon 0.15 miles, more or less, and being 790 feet long by 18 feet wide, and being the portion of Robert Stuart located North of Highway 436, agree and request that the Washington Parish Government abandon the same and remove it from the parish inventory.

**BE IT ORDAINED** by the Washington Parish Council that a portion of Robert Stuart, measuring 0.15 miles, more or less, and being 790 feet long by 18 feet wide, and being the portion of Robert Stuart Road located North of Highway 436 listed on the Washington Parish Inventory List as Parish Road No. 5-153, be and is hereby abandoned by the Washington Parish Government and removed from the Parish Road inventory.

**BE IT FURTHER ORDAINED** that the above-described property to be abandoned shall be subject to all existing utility servitudes.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


