**RESOLUTION ACCEPTING THE SIDEWALK IMPROVEMENTS
IN DOWNTOWN FRANKLINTON THROUGH
STATE PROJECT NO. H.011835,
LA 25: WASHINGTON PARISH SW, SEG B AND C
AND FEDERAL PROJECT NO. H.011835**

WHEREAS, Article VII, Section 14(C) of the Constitution of the State of Louisiana provides that “for a public purpose, the state and its political subdivisions...my engage in endeavors with each other; and

WHEREAS, under the provisions of Title 23, United States Code, “Highways” as amended, funds were appropriated out of the Federal Highway Trust Fund to finance improvement projects under the direct administration of the Department of Transportation and Development which the Washington Parish Government requested an appropriation of these funds to finance a portion of the above reference project; and

WHEREAS, Washington Parish Government entered into an Intergovernmental Agreement with the Town of Franklinton for DOTD Federal Aid Sidewalk Project H.011835 dated February 18, 2020; and

WHEREAS, State Project No. H.011835 and Federal Project No. H.011835 for sidewalk improvements in downtown Franklinton, Louisiana being approximately 5200 linear feet of sidewalks along Main Street (LA 25), Washington Street (Highway 10), Cleveland Street and Pearl Street has been completed.

BE IT RESOLVED that the Washington Parish Government accepts the sidewalk improvements in downtown Franklinton, Louisiana through the DOTD Federal Aid Sidewalk Project H.011835 as completed.

BE IT FURTHER RESOLVED that the Town of Franklinton is determined the “Roadway Owner” of the non-roadway enhancement sidewalk improvements as per the Agreement between the Washington Parish Government and the State of Louisiana Department of Transportation and Development and, therefore, The Town of Franklinton assumes the ownership and maintenance of the specified improvement at its expense in a manner satisfactory to the Federal Highway Administration.
