**A RESOLUTION EXTENDING THE MORATORIUM  
ON THE APPROVAL OR PERMITTING  
OF ALL SOLAR PANEL FARMS OR UTILITY SCALE SOLAR  
PROJECTS, COMMERCIAL SOLAR POWER PLANTS  
OR OPERATIONS SIMILAR THERETO**

**WHEREAS**, the Washington Parish Council adopted Resolution 21-1075 on March 22, 2021 placing a moratorium on the approval or permitting of all solar panel farms, commercial solar power plants or operations similar thereto on all property within the jurisdiction of the Washington Parish Government, excluding state-owned land for a period of ninety (90) days unless further extended or cancelled sooner; and

**WHEREAS**, due to information continuing to be collected by the Washington Parish Council and its committees for the development of solar panel farms or utility scale solar projects, commercial solar power plants or other operations similar thereto resulting in the need for continued review and final determination of the need for the development of an ordinance or ordinances related thereto.

**BE IT RESOLVED**, that the Washington Parish Council hereby extends the moratorium adopted by Resolution 21-1075 on the approval or permitting of all solar panel farms or utility scale solar projects, commercial solar power plants or operations similar thereto on all property within the jurisdiction of the Washington Parish Government, excluding state-owned land, for an additional period of sixty (60) days from June 20, 2021 (being date of expiration Resolution 21-1075), unless further extended or cancelled sooner.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:


