RESOLUTION No. 21-1089

**AMENDING RESOLUTION NO. 20-1014
TO PROVIDE LAWN MAINTENANCE FOR A PROPOSED
VETERANS MEMORIAL PARK**

WHEREAS, by Resolution No. 20-1014 adopted on June 8, 2020, the Washington Parish Government was authorized by the Washington Parish Council to provide the labor and equipment to perform lawn maintenance consisting of mowing and weed-eating of the veterans memorial park on property owned presently by Louisiana State University and more particularly described in Resolution No. 20-1014; and

WHEREAS, Resolution No. 20-1014 stated that the Washington Parish Government will begin lawn maintenance upon the execution of a lease by Louisiana State University to Our Veterans Memorial Park, Inc., completion of construction of the park and being provided with proof of liability insurance with the Washington Parish Government being an additional insured; and

WHEREAS, at this time, upon information and belief, a lease between Louisiana State University and Our Veterans Memorial Park, Inc., has not been executed; construction of the park has not begun due to fund-raisers having recently commenced for the funding of the construction. However, Our Veterans Memorial Park, Inc. has requested that the Washington Parish Government begin lawn maintenance on the site; and

WHEREAS, it has been determined that the Washington Parish Government is not required to be listed as an additional insured on a liability insurance policy.

THEREFORE, BE IT RESOLVED, that due to the above, the Washington Parish Government will commence lawn maintenance on as "as-need" basis and at its discretion, on the property owned by Louisiana State University to be leased to Our Veterans Memorial Park, Inc., more particularly described in Resolution 20-1014 as long as Our Veterans Memorial Park, Inc. is progressing with its plans and the construction of the veterans memorial park.

BE IT FURTHER RESOLVED, that the Washington Parish Government is not required to be listed as an additional insured on a liability insurance policy.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
