**RESOLUTION CHANGING THE POLLING PLACE OF WARD 4,  
PRECINCTS 10, 10A and 11 FROM THE PALESTINE BAPTIST  
CHURCH HALL TO THE RIO FIRE STATION FOR THE  
DECEMBER 11, 2021 ELECTION IN THE STATE OF LOUISIANA**

**WHEREAS**, La. R. S. 18:534 authorizes a parish governing authority to change a polling place; and

**WHEREAS**, special circumstances have arisen at the current location of the polling place in Ward 4 Precincts 10, 10A and 11 at the Palestine Baptist Church Hall having a physical address of 59369 Palestine Church Road, Bogalusa, Louisiana 70427 wherein the premises cannot be used for a polling place for the election to be held on December 11, 2021.

**THEREFORE BE IT RESOLVED**, that the polling place located in Ward 4 Precincts 10, 10A and 11 at the Palestine Baptist Church Hall having a physical address of 59369 Palestine Church Road, Bogalusa, Louisiana, 70427 is hereby changed for the December 11, 2021 election ONLY to the Rio Fire Station, having a physical address 12022 Hwy. 1075, Bogalusa, Louisiana 70437 which is located in Ward 4 Precincts 10, 10A and 11.






