RESOLUTION NO. 21-1136

**RESOLUTION BY THE WASHINGTON PARISH COUNCIL TO AUTHORIZE
THE PARISH PRESIDENT TO SIGN AN INTERGOVERNMENTAL
AGREEMENT TO ASSIST THE CITY OF BOGALUSA WITH SKILLED
LABOR AND MECHANIZED EQUIPMENT TOWARDS DRIVEWAY,
PARKING AREA, ROAD REHABILITATION, DRAINAGE AND FLOOD
CONTROL**

WHEREAS, Article VII, Section 14 (C) of the Constitution of the State of Louisiana provides that, "for a public purpose, political subdivisions or political corporations may engage in cooperative endeavors with each other, with the United States or its agencies, or with any public or private association, corporation, or individual;" and

WHEREAS, there is a lack of mechanized resources from the City of Bogalusa to complete driveway, parking, roadway and flood control projects deemed to be critical for Asphalt Rehabilitation and Controlling Surface Water Runoff projects.

WHEREAS, various political subdivisions, including the City of Bogalusa, require assistance from time to time to meet the demands for road construction and control localized flooding.

WHEREAS, savings may be realized by two political subdivisions sharing the services of skilled labor and mechanized equipment without sacrificing the level of road maintenance and flood control services.

WHEREAS, the City of Bogalusa desires to utilize the services of skilled labor and equipment employed by and owned by the Washington Parish Government.

WHEREAS, the City of Bogalusa will provide the construction materials to be used within the jurisdiction of the City of Bogalusa; therefore, the City of Bogalusa will purchase the necessary materials to construct roads and control localized flooding in order to complete construction performed by the Parish.

AND WHEREAS, in consideration of these services and advantages to be received by the general public provided by both Parish and City of Bogalusa,

BE IT RESOLVED that Washington Parish Council hereby authorizes the Parish President to sign an intergovernmental agreement to assist the City of Bogalusa with skilled labor and mechanized equipment towards road rehabilitation, drainage and flood control.

The above and foregoing having been submitted to a vote, the vote thereupon resulted as follows:
