RESOLUTION BY THE WASHINGTON PARISH COUNCIL TO AUTHORIZE THE PARISH PRESIDENT TO SIGN AN AGREEMENT BETWEEN MEYER ENGINEERS, LTD. AND WASHINGTON PARISH GOVERNMENT TO PROVIDE ENGINEERING SERVICES FOR SIDEWALK CONSTRUCTION IN DOWNTOWN FRANKLINTON THROUGH STATE PROJECT NO. H.014913

WHEREAS, The Washington Parish Government, a political subdivision of the State of Louisiana, requests authorization by the laws of the State of Louisiana to enter into an agreement with Meyer Engineers, LTD for engineering services on a sidewalk grant project to be constructed in downtown Franklinton through State Project No. H.014913; and

WHEREAS, Meyer Engineers, LTD is certified as required by DOTD and has been involved in the initial design work leading to the current approval of funding as a Federal and State project; and

WHEREAS, Washington Parish Government has requested an appropriation of DOTD funds from the Transportation Alternatives Program (TAP) to finance 80% of the above referenced Project with Parish Government responsible for remaining 20% plus the engineering fees; and

WHEREAS, the Parish, State and Federal government each has a demonstrable, objective and reasonable expectation of receiving a public benefit in the form of improved safety and positive economic development at least equivalent to or greater than the amount of each party's contribution, including the Federal share.

THEREFORE, BE IT RESOLVED that the Washington Parish Council hereby authorizes the Parish President to sign an agreement between Meyer Engineers, LTD and Washington Parish Government for engineering services to allow construction of sidewalks in downtown Franklinton through State Project No. H.014913.


