**AN ORDINANCE TO LEVY TAXES FOR 2022 –
MILLAGE AT THE SAME RATE AS PRIOR YEAR - ON
PROPERTY SUBJECT TO TAXATION IN WASHINGTON PARISH**

WHEREAS, the Washington Parish Council, governing authority of the Parish of Washington, State of Louisiana, held a public meeting on May 9, 2022, conducted in accordance with the open meetings law.

BE IT ORDAINED, by the Washington Parish Council, that the following millages are hereby levied on the 2021 tax roll on all property subject to taxation in Washington Parish.

BE IT FURTHER ORDAINED that the proper administrative officials of the Parish of Washington, State of Louisiana, be and they are hereby empowered, authorized, and directed to spread said taxes, as hereinabove set forth, upon the assessment roll of said Parish for the year 2021, and to make the collection of the taxes imposed for and on behalf of the taxing authority, according to law, and that the taxes herein levied shall become a permanent lien and privilege on all property subject to taxation as herein set forth, and collection thereof shall be enforceable in the manner provided by law.

The foregoing Ordinance was read in full; the roll was called on the adoption thereof, and the ordinance was adopted by the following votes:






